Introductions and announcements from candidates were made.

Vicki Kline thanked the group the opportunity to speak and informed the group of her desires and qualifications to be Portage County Commissioner. Tommie Jo Marsilio opened with "I will not just talk but do", explaining how she will put an end to all the bad headlines Portage County has been receiving. Portage County Auditor Janet Esposito recapped on the programs she has put in place and how they have benefited Portage County and how she will continue to work for us.

Shalersville Township - Dorothy Caldwell reported Crestwood Lions Club donated their time and painted the park pavilion. The new brick entrance sign for Hillside Cemetery and the re-sealing of the drives at Riverside Cemetery projects are complete. They also installed 28 monument foundations. A total of 8.87 miles of road improvements have been completed. The salt shed is now complete, many thanks to everyone who donated materials. Trick or Treat is scheduled for Sunday Oct. 31 2-5 pm.

Mantua Township - Marie Stehli reported ongoing work to Benning, Crackle, and Harner roads. 60% of this project is funded with issue II money. They are awaiting information on a NOPEC grant which if received will provide funding to replace various township windows and doors. Trick or Treat Sunday Oct. 31 5 to 7 pm

Guest Speaker- DuWayne Porter from Portage County Health Department requested our support in passing issue 10, a .4 mil Portage County Health levy. The passing of this levy will cost a homeowner \$1.05 per month on a \$100,000 home. He went on to say that the health department is running on the lowest operating budget of any similar size in the state. They are operating with only 24 staff members and serve 115,000 residents.

Other Issues on the Ballot - Marie Stehli also spoke about issue #19 for Mantua Township, and reported on issue #14 and #15 for the Mantua Village.
