EVENT DESCRIPTION: “Art on the Hill & Wine Tasting 2017”, hosted by the Downtown Mantua Revitalization Corporation (DMRC) is a day-long festival of the arts. Attractions include: artists and craftsmen displays and artwork sales, local food vendors, demonstrations, children’s activities and so much more! The DMRC is a non-profit, 501(c)(3) organization whose mission is to develop and implement a consensus-based plan to enhance the appearance of downtown Mantua. To date, the organization has provided numerous improvements to the Village of Mantua!

LOCATION: East Prospect Street in the village of Mantua. Mantua is located 4 miles south of the intersection of state routes 422 & 44 and 4 miles north of Ohio Turnpike exit 193.

DATE & TIMES: Saturday, July 8, 2017 - Event begins at 10 am & closes at 6 pm. Set up 7-9 am. Set up times will be assigned by booth number. Tear downs is prohibited before 6 pm.

AWARDS: Awards for the “Best Booth Presentation”, “Best Demonstration”, and “People’s Choice Most Creative Artwork” will be presented.

ADVERTISING: The event is well advertised to ensure a large attendance. Advertisements are placed in dozens of local newspapers, event brochures and programs, as well as on websites, facebook, and other social media outlets. Past artisans also promote the event with provided flyers at events they attend prior to ours. Please let us know if you would like to receive these flyers to display in your booth at previous events. We will gladly mail them to you!

BOOTH INFORMATION: “Art on the Hill & Wine Tasting 2017” is an outdoor venue. There are 100+ 10’ x 10’ booth spaces. Artists/food vendors must supply their own canopy (if desired), display equipment, tables, chairs, etc. For safety, artists need to bring appropriate weights to secure their booths. Spikes and staking are not allowed, nor is tying off to any street fixture, permanent or temporary.

BOOTH FEE: \$55 and is due with this application. If your setup area requires space exceeding 10’ x 10’, ‘double booths are available for \$100. Sorry, we cannot refund booth fees for any reason. The deadline for booths requiring electric is June 20, 2017. If electric is required, an additional fee of \$20 will be due with this application so the appropriate number/size of rental generators can be arranged. Vendors must supply their own heavy duty outdoor 12 gauge extension cord. Generator use is permitted, however, 100’ of cord is required to use a generator at the event.

ELIGIBILITY: “Art on the Hill & Wine Tasting 2017” is open to all artists within the accepted medium categories. No work from commercial molds, kits, or manufactured work is accepted. Exhibitors are prohibited from selling non-original promotional items (posters, t-shirts, etc).

INCLUSION IN EVENT PROGRAM: All artisans and food vendors will be included in the “Art on the Hill & Wine Tasting 2017” event program which is available as a additional advertising prior to and at the festival. Application must be received by June 20, 2017 to be included in the program.

ART/PRIZE DONATION: Since “Art on the Hill & Wine Tasting 2017” is a fundraiser, each artist is asked to donate an item to the Chinese Auction held on the day of the event. Our organization is a non-profit 501(c)(3) which makes your donation tax-deductible. Artists may place business cards near their donation for additional advertising of their wares.
